## Task Force Meeting Notes Woodbridge Association Inc. of Kings Mountain, NC Monday May 2nd, 2022

Concerns were brought up about animal/s leaving the owner's property; the Board is meeting after with plans to discuss and evaluate per current regulations and by laws. However this is one part of the regulations this group (task force) is working to specify.

 Concerns brought up do need tangible evidence of offense against restriction and by laws as in video recordings, written statements by eyewitnesses, pictures/recording on cell phones (date/time stamped), and any other documentation (animal control, sheriff dept., and etc.).

Concerns about loud noises (Restrictions 2. Nuisances) at all times of the day and night. The Restrictions need more detail or better wording on what is considered a nuisance. The restrictions are too vague inorder to be enforced, this is why the task force was developed.

- City of Shelby has a noise ordinance we could compare to see if there are pieces we could use in our restrictions.
- Listing appropriate decibels during specific hours was suggested.
  - Example: Between 10pm through 5am no sound louder than 30 decibels with exception of first responders.

Repercussions for breaking the Restrictions are listed in the North Carolina State Planned Community Act.

The task force decided to subdivide into smaller groups in order to accomplish draft rewriting/amending regulations efficiently. The subcommittees will be working on specifics that these topics need to entail in order to be enforced/regulated fairly. The topics of the subcommittees were decided by highest priority, most brought up to the board, and regulations hardest to enforce.
